Apply 1 to 2 quarts per acre (0.75 - 1.5 fluid ounces per 1000 square feet) with sufficient water for coverage.

Do not apply near water, storm drains or drainage ditches. Do not apply in heavy rain is expected. This product may only be applied to the intended application site.

STORAGE AND DISPOSAL

STORAGE: Store at ambient temperatures in dry secure area. Keep container tightly closed.
